A BILL

To amend the Foreign Agents Registration Act of 1938, as amended, to require registration statements filed under that Act to be filed in a structured data format to enable the statements to be digitized for purposes of the publicly available electronic database maintained under that Act, and for other purposes.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Foreign Agents Reg-
5 istration Modernization Act of 2021”.

1 **SEC. 2. MODIFICATIONS RELATING TO FARA REGISTRA-**
2 **TION STATEMENTS.**

3 (a) **FORMAT.**—

4 (1) **IN GENERAL.**—Section 2(g) of the Foreign
5 Agents Registration Act of 1938, as amended (22
6 U.S.C. 612(g)), is amended—

7 (A) in the subsection heading, by striking
8 “ELECTRONIC” and inserting “FORMAT FOR”;
9 and

10 (B) by striking “shall be filed” and all that
11 follows through the period at the end and in-
12 serting the following: “shall be filed in—

13 “(1) an electronic, structured data format
14 under which the statement or supplement shall be
15 published in a publicly available, machine-
16 processable digital format for purposes of the Na-
17 tional Foreign Agents Database under section
18 6(d)(1); and

19 “(2) such other formats as the Attorney Gen-
20 eral may require.”.

21 (2) **EFFECTIVE DATE.**—The amendments made
22 by paragraph (1) shall apply with respect to state-
23 ments and supplements filed under section 2 of the
24 Foreign Agents Registration Act of 1938, as amend-
25 ed (22 U.S.C. 612), on or after the date that is 180
26 days after the date of enactment of this Act.

1 (b) ELECTRONIC DATABASE.—

2 (1) SEARCHABILITY AND SORTABILITY; DES-
3 IGNATION.—Section 6(d) of the Foreign Agents Reg-
4 istration Act of 1938, as amended (22 U.S.C.
5 616(d)), is amended—

6 (A) in the subsection heading, by striking
7 “UPDATES” and inserting “SUPPLEMENTS”;
8 and

9 (B) in paragraph (1)—

10 (i) in the matter preceding subpara-
11 graph (A), by striking “to the extent tech-
12 nically practicable, an electronic database
13 that” and inserting “an electronic data-
14 base, to be known as the ‘National Foreign
15 Agents Database’, that”; and

16 (ii) in subparagraph (A), by striking
17 “includes the information contained in reg-
18 istration statements and updates” and in-
19 serting “includes, in a digitized format
20 that achieves compliance with the applica-
21 ble digital accessibility standards described
22 in section 508 of the Rehabilitation Act of
23 1973 (29 U.S.C. 794d), the information
24 contained in registration statements and
25 supplements”.

1 (2) POSTING ON RECEIPT.—Section 6(d)(2) of
2 the Foreign Agents Registration Act of 1938, as
3 amended (22 U.S.C. 616(d)(2)), is amended—

4 (A) by striking “update” each place it ap-
5 pears and inserting “supplement”; and

6 (B) by striking “as soon as technically
7 practicable” and inserting “immediately”.

8 (3) EFFECTIVE DATE.—The amendments made
9 by this subsection shall take effect on the date that
10 is 180 days after the date of enactment of this Act.
